IN RE: **Authorization of Reimbursement Fees for Fire Department Services**

AMENDED ORDER

THIS 28th day of June, 2018, the Putnam County Commission does hereby authorize and approve, pursuant to West Virginia Code §7-~~3~~¹-3d, any volunteer or paid fire department located within Putnam County or any volunteer or paid fire department that responds to an incident or accident in Putnam County, to assess the following reasonable fees for personnel and equipment used in performing fire-fighting services, victim rescue or cleanup of debris or hazardous materials by fire department personnel:

<u>Service/Equipment</u>	<u>Rate Per Hour</u>
Engine Truck	\$250.00
Rescue Truck	\$200.00
Ladder Truck	\$300.00
Utility Truck	\$ 50.00
Tanker/Pumper Truck	\$150.00
Squad (EMS 1 st response vehicle)	\$100.00

A fire department may charge more than the above rates if reasonable and first approved by the Putnam County Commission; Provided, however, that no fee for any single incident or accident may exceed fifteen hundred dollars (\$1,500.00), except that the fee for an incident or accident involving hazardous material or extended search and rescue and water rescue incidents may exceed this amount based on the necessary and reasonable costs incurred; Provided further, that in no case may charges for these services be assessed against a property owner or person

responsible or liable for payment of such services when said person has paid, prior to the accident or incident, the annual service fee due for the year in which the accident or incident occurs.


Furthermore, any fees charged hereunder must be reasonable, in writing and itemized by specific services rendered and the rates therefor.
