Computation of Time

"If any applicable provision of this code or any legislative rule or other administrative rule or regulation . . . designates a particular date on, before or after which an act, event, default or omission is required or allowed to occur, and if the particular date designated falls on a Saturday, Sunday, legal holiday or designated day off, then the date on which the act, event, default or omission is required or allowed to occur is the next day that is not a Saturday, Sunday, legal holiday or designated day off."

"When a proceeding is directed to take place or any act to be done on any particular day of the month or within any period of time prescribed or allowed . . . if that day or the last day falls on a Saturday, Sunday, legal holiday . . . the next day that is not a Saturday, Sunday, legal holiday . . . shall be deemed to be the one intended"

January 1 - May 6, 2026	<p>Accept Absentee Ballot Applications for Primary Election from Eligible Voters</p> <p>Eligible voters may submit an absentee ballot application to the County Clerk during the designated period. The application must be completed in the voter's own handwriting and can be submitted in person, by mail, or electronically. Applications may be received starting January 1 in the year of the Primary Election and not later than 6 days before the Primary Election.</p> <ul style="list-style-type: none"> - W. Va. January 1 - May 6, 2026	<p>Accept Absentee Ballot Applications for Primary from Military and Overseas Voter (UOCAVA)</p> <p>UOCAVA voters may submit an absentee ballot application to the County Clerk during the designated period. The application can be submitted in person, by mail, or electronically. Applications may be received starting January 1 in the year of the Primary Election and not later than 6 days before the Primary Election. UOCAVA absentee applications are valid for all elections held in the year they are submitted. - Determine the number of persons who may be instructed to attend training as alternates.
