WHAT SHOULD I DO WHEN THE FIRE ALARM SOUNDS?

1. Do not call Security, Building and Grounds or 911 to inquire about the cause. Leave the building immediately.
2. Exit the building in an orderly fashion and report to your supervisor at the designated reporting area, which is the parking lot area between the Sheriff's Department and the Judicial Building.
3. Do not use the elevator.
4. Be cognizant of those around you who may need assistance in exiting the building.
5. Return to your workplace only after receiving clearance from emergency personnel.
