6. Construction requirements in *Article 1400 Signs in the Zoning ordinance for the Zoned Unincorporated Areas of Putnam County, West Virginia*

A scaled site plan must be submitted with the application for all newly constructed freestanding signs and shall include the following: (NOTE: this scaled site plan may be hand-drawn)

- 1. Boundary lines of the property
- 2. Sign location(s), existing and proposed
- 3. Utility easements
- 4. Drainage easements
- 5. Rights-of-way
- 6. Distances from rights-of-way and easements
- 7. Location of external lighting

A lighting plan by a registered professional engineer must be submitted for external lighting that demonstrates there will not be a safety issue with oncoming vehicular traffic and if adjacent to residential property, that there will be a maximum of 0.2 FC at property line.
